Document Title: Accreditation Federation (AF) - Official Membership & Fee Guide

OFFICIAL MEMBERSHIP & FEE GUIDE

1. Membership Categories & Fees

Membership Type	Annual Fee (EUR)
Global Accreditation Groups (GAG)	2,500
Accreditation Organization (AB)	2,500
Conformity Assessment Body (CAB)	2,500
Institutions (Educational, Research, etc.)	2,500
Organizations (Non-AB/CAB institutions, associations, corporations)	2,500
Scheme Owners	2,500
Individual Members	500

Note:

- Annual membership fees cover basic Federation services, participation in selected committees, and standard membership benefits.
- Fees are subject to periodic review. Any changes will be communicated in advance to all members.

2. Multilateral Recognition (MR) Membership

MR Membership Fee: 5,000 EUR (annually)

For Individuals: 1,500 EUR (annually)

Special Rule: Members who obtain MR membership do not pay the regular membership fee (2,500 EUR). As long as MR status is maintained, the annual fee is 5.000 EUR.

External Accreditation Bodies Recognized under MR: Must also pay 5,000 EUR if recognized as MR members.

3. Accreditation Application & Evaluation

Accreditation Application & On-Site Evaluation:

If the accreditation application and evaluation audit are carried out by AF (AF Accreditation Counsil), the audit duration and the fees for the Accreditation Decision Committee will be applied accordingly.

- Audit Man-Day Rate: 1,400 EUR
- Accreditation Decision Committee Fee: 800 EUR

Travel & Subsistence: Travel, accommodation, daily allowances, and personal expenses are invoiced separately based on actual costs.

Process Flow:

- Application submission
- Document review and scheduling
- On-site or remote evaluation by qualified auditors/assessors
- Accreditation Decision Committee review (and any follow-up actions)
- Final accreditation certificate issued upon approval

5. Additional Notes

• MR Membership Exemption: Once an organization or individual obtains MR status, their total annual fee is the MR fee (5,000 EUR), not

the standard membership fee.

- **Accreditation Fees:** The final cost of accreditation depends on the number of audit days, complexity of the operation, and the travel/logistical arrangements needed.
- Policy Updates: AF reserves the right to update membership fees and accreditation guidelines to ensure alignment with international standards and best practices.
- **Refunds & Cancellations:** In the event of membership or accreditation cancellation, partial refunds may be issued according to AF's written refund policy.
